### Legislative Advisory

K. McClure reported that general assembly session ended on Saturday. Of course, there was the injunction stopping action on the pensions. The budget was flat for next year. No action was taken on the temporary tax increase. The state is relying on borrowing \$650 million from dedicated state funds to repay in 18 months. So payment to vendors will be delayed, so same thing as in the past. There was a billion dollar capital bill passed to fix roads and bridges. The Minimum Wage Act should appear on the ballot in fall.

### Council of Councils Committee

Diane Frew reported that the Council identifier had been ordered and was approved. This identifier can be used on shirts, etc. as well as any printed material.

### Campus Climate Committee

Matt Borowicz reported the committee met and discussed strategies and what kind of information was needed from campus. The committee wanted to get the council's opinion as far as issues, etc. Borowicz distributed a handout to be filled out by council members and given back to the committee for review.
